SHOTGUN RANGE RULES

1. Eye and ear protection is mandatory for all individuals on any range during shooting hours **No exceptions**
2. Actions of any gun must be open and muzzle must be pointed in a safe direction when not on a shooting station
3. Only approved ammunition is allowed. No shot larger than 7 1/2 or dram equivalent greater than 3 drams is permitted. **No exceptions**. Absolutely no hunting loads will be permitted. Steel target loads of a shot size of no. 7 will be permitted
4. No gun may be loaded until the shooter is on the station
5. No more than 2 rounds may be loaded at any time
6. Only one shot is allowed per target
7. Shooting at broken targets or chips is not allowed
8. Members must be present when their guest(s) are shooting
9. Under age shooters must be attended at all times. Only one gun is permitted between a non-licensed shooter and his / her mentor
10. No restricted firearms are permitted at any time on any range
